

# Carriers killed, injured in line of duty

**I**t has been a sad few months for carriers across the country, with two carriers having died while delivering mail and a third having survived a crippling accident.

In Los Angeles, a car crash on Feb. 28 pinned Branch 24 member Anthony Earl Dunn II between a car and his postal vehicle. The 31-year-old Dunn was standing behind his vehicle when the crash occurred. Though he survived the crash and was taken to the hospital for an initial surgery, he died from his injuries the next day. Police said that the driver of the car had a revoked license.

The crash follows a similar accident in Columbus, OH, in January when Branch 78 member Doug Poole was hit by an SUV while unloading mail from the rear of his vehicle. The 17-year carrier still is in the hospital, though he has had his last scheduled surgery. It's questionable whether he'll regain the use of his legs.

Most recently, 59-year-old transitional employee Diane Jansen died after an attack from a pit bull while on a swing route in Escondido, CA, on March 1. The Branch 2525 member "developed slurred speech and became unresponsive" while being examined by medical personnel, according to the medical examiner. Suffering a stroke resulting from hypertension and cardiovascular disease, with the dog bites listed as a contributing

condition, Jansen was taken to the hospital in poor condition. She was removed from life support on March 3 and died the next day. The dog was euthanized with the owner's permission.

"As a union, we stand by the ideal that no carrier should come to harm on the job," NALC President Fredric Rolando said. "But accidents happen, sometimes with horrific results. I know I'm not alone in praying for the victims and their family and friends.

"But when the prayers are over, we must rededicate ourselves as a union to prevent accidents like these in the future."
