

## BLOOD DRIVE

ALC, in conjunction with the American Red Cross in Hennepin County, will hold a blood drive on Tuesday, July 24, and Wednesday, July 25, from 9 a.m. to 3 p.m. at the Minneapolis Convention Center in room M100 on the Mezzanine Level. The Red Cross hopes to collect 200 units per day.

Members are strongly encouraged to sign up in advance using the online scheduler at redcrossblood.org. Click on the "Make a Blood Donation Appointment" and enter the Sponsor Code: 0177712. The NALC Convention Center drive will appear. Click on the link that says "To Schedule an Appointment." It will bring you to the donor login page. You need either to click on "Create a New Account" or, if you have donated to the American Red Cross recently, to enter your username and password. You then will be directed to the NALC Convention sign-up sheet. After this, you may select an appointment time.

You also may schedule your appointment by calling 800 RED CROSS (800-733-2767); pressing 2 and giving your sponsor code 0177712.

Members also may opt to donate "double red cells." For information that explains double red cell donation, go to NALC's convention page.

If you do not have the opportunity to schedule an appointment in advance, on-site appointments may be made based on availability.

#### **Blood donors must:**

- Be healthy (meaning that you feel well and can perform normal activities).
  - ❖ Be at least 17 years old.
  - Weigh at least 110 lbs.
- If you donate blood after May 28, you will not be eligible to donate at this drive.

# GETTING AROUND MINNEAPOLIS

Bing City Letter Carriers, most of the delegates to the 2012 national convention will enjoy walking to hotels, restaurants, shops and the Minneapolis Convention Center this July. But there are other ways to get around town.

Except for hotels located within easy walking distance, shuttle buses will serve most of the 19 official NALC hotels to take delegates to and from the convention center. A vehicle with a wheelchair lift will be available on an oncall basis to serve any hotel. There is ample parking, including handicapped parking, at the convention center.

A discount on shuttle service between Minneapolis-St. Paul International Airport and downtown hotels is available for delegates. For more information on reservations, discounts and other transportation options, go to nalc.org/news/conv.

A light rail transit line, the Hiawatha Line, runs from both airport terminals to downtown. The Hiawatha Line also connects the downtown area to the Mall of America in Bloomington. The Government Plaza station is seven blocks from the convention center. Buses connect from downtown stations to most parts of the city. Bus routes 10 and 25 run between the Nicolett Mall station and the convention center, part of a large bus network that runs throughout the city. For more information on buses or light rail, go to metrotransit.org/light-rail. Amtrak also serves the region with a stop in St. Paul.

A bicycle is never far away, thanks to the NiceRide bike-sharing system. With a credit card, you can instantly rent a bike at any of these automated stations and return it at any NiceRide station with an empty port. There is a station adjacent to the convention center at the corner of E. Grant Street and Marquette Avenue. See niceridemn.org for more information.

In winter, the Skyway keeps Minneapolis pedestrians warm and clear of snow and ice through much of downtown, but it's a good way to get around in the summer, too. The Skyway is a network of second-floor spaces in buildings, including the convention center and several hotels, connected by enclosed bridges over streets. It provides access to many restaurants and shops—more than enough to fill a day of walking indoors. Most buildings limit the hours they allow public access through the Skyways. NALC is offering several tours of Minneapolis area attractions throughout the convention at reasonable cost, including boat trips, plus trips to casinos, the Minneapolis Zoo, wineries, the historic town of Stillwater, MN, and a Wabash Caves and gangster tour with costumed guides. Space is limited, so advance registration is strongly advised.

## TIME LIMITS WAIVED

The NALC and the Postal Service have agreed to a waiver of time limits during July and August for all grievances because of the union's 68th Biennial Convention, which takes place in Minneapolis, July 23-27.

The agreement, signed by NALC President Fredric Rolando and USPS Vice President—Labor Relations Doug Tolino, covers all parties at the local, regional and national levels for the 31 days starting July 15 and ending on Aug. 14.

# PROPOSED AMENDMENTS TO THE NALC CONSTITUTION

The following proposed amendments to the *NALC Constitution* will be considered by the delegates to the 68th Biennial Convention in Minneapolis. Prosposed new language is printed in **bold**; strike through indicates proposed language to be deleted. The *Constitution* is available on the NALC Website at nalc.org/depart/sectreas/publications.html.

#### NALC CONSTITUTION Branches, State Associations, Membership

Amend Article 2, Section 2 as follows:

Section 2. All members of the National Association of Letter Carriers shall be affiliated with a Subordinate Branch and with the State Association, if one exists, in the State in which their branch shall have jurisdiction over members working under one or more Postmasters as determined by the branch charter. In the event the Postal Service shall combine one or more offices into one with a single Postmaster, the smaller branch or branches shall be merged with the largest branch into one branch, provided the provisions of Article 2, Section 3(e) are complied with. The number of any NALC members in the Branch will determine which is the largest. When the Postal Service shall separate one office into more than one office, the following shall apply: The smaller minority of these groups shall have the option, by majority vote, to continue their membership in the original subordinate branch, and alson the case of rural carriers, may form a county subordinate branch or affiliate with a subordinate branch in the adjacent city.

NALC Executive Council

Amend Article 2, Section 5 (b) as follows:

(b). When receiving proper notification by the Branch Secretary that a member has completed fifty-five (55), sixty (60), or sixty-five (65) years of membership, the National Association of Letter Carriers shall provide a suitable lapel button to such member.

Branch 15, Providence, RI

Amend Article 2. Section 5 as follows:

Section 5 (a) When receiving proper notification by the Branch Secretary that a member will complete twentyfive (25) years, or thirty (30) years, or thirty-five (35) years, or forty (40) years, and forty-five (45) years of membership, the National Association of Letter Carriers shall provide a suitable lapel pin to such member. In the year when a member is to complete fifty (50) years membership in this Association, and by proper request having been directed by the Branch Secretary to the National Secretary-Treasurer, a member shall be given a Life Membership Card of gold which shall entitle him/her to all privileges of membership in the National Association of Letter Carriers without payment of dues, per capita tax, or special assessments from the date of issue of such Life Membership Card; provided, however, that a Life Member shall not be exempt from the requirements of premium payments to the Mutual Benefit Association or the Health Benefit Plan. Life Members shall also be issued a suitable lapel pin. The Life Membership Card and the lapel pin shall be issued by the National Association through the office of the National President

Section 5 (b) In the year when a member is to complete fifty-five (55) years, sixty (60) years and sixty-five (65)

years and when receiving proper notification by the Branch Secretary, the National Association of Letter Carriers shall provide a suitable lapel pin to such member.

Section 5 (c) In the year when a members is to complete seventy (70) and seventy-five (75) years and when receiving proper notification by the Branch Secretary, the National Association of Letter Carriers shall provide a suitable plaque for such member.

Branch 3, Buffalo/Western NY

Amend Article 2, Section 5 by adding the following new item (d):

All provisions of this article shall also apply to those members that were city letter carriers but were denied NALC membership and joined the National Alliance of Postal Employees. To qualify, reasonable proof of membership longevity in both the NAPE and the NALC must be provided.

Branch 9, Minneapolis, MN

Amend Article 2, Section 5 by adding the following new item (d):

For purposes of this Article 2, Section 5, membership in the National Alliance of Postal Employees prior to January 1, 1969 shall be treated as equivalent to membership in the National Association of Letter Carriers.

## Time and Place of Conventions and Special Meetings

Amend Article 3, Section 1 as follows:

The national Convention of this Union shall be held 'Triennially' between the Fourth of July and third full week of August.

If approved by the NALC Executive Council; Applicable sections of Article 6 relating to the length of terms of office must be changed to coincide with the revised National Convention schedule.

Branch 6156, Sun City, AZ

#### **Elections**

Amend Article 5, Section 5 (c) as follows:

Elections shall be by secret ballot. When there are more candidates for delegate and alternate Delegate than the authorized number for the Branch, the election shall be by ballot, and the candidates receiving the largest number of votes shall be elected. There shall be no write-in votes for candidates not officially on the ballot. Any such write-in shall not be counted, but will not invalidate the rest of the ballot. Each eligible regular member shall be entitled to one vote for each delegate or alternate position to be filled. Where there are fewer or the same number of candidates as the number of delegates and alternates for which the Branch is authorized, the President may declare that such persons have been elected. Adequate safeguards to ensure a fair election shall be provided, including the right of any candidate to have an observer at the counting of the votes and at any polling place. The National Executive Council is hereby empowered to adopt and promulgate rules and regulations for the conduct of all elections. This shall include Branches, State Associations and National elections which will provide such adequate safeguards. The election will be held at a regular meeting of the Branch; or a Branch may provide in its bylaws that ballots may also be cast at each station not

more than seven(7) days, nor less than one(1) day, before the regular meeting; or that the election shall be by secret mail ballot. Whenever such elections are conducted by mail ballot, the last date on which the ballots must be received in order to be counted shall be considered to be the date of the election. The Recording Secretary shall preserve for one year the ballots and all other records pertaining to the election.

#### Officers and Elections

Amend Article 6, Section 2 as follows:

Section 2. Every four (4) years, nominations for officers of the Union shall be called by the Chairperson of the Convention on the third day (Wednesday) of the Convention. The Chair shall call for nominations from the floor for each national office separately. Any delegate may nominate an eligible member for any one of the following national offices: President, Executive Vice President, Vice President, Secretary-Treasurer, Assistant Secretary-Treasurer, Director of City Delivery, Director of Safety and Health, Director of Life Insurance, Director of Health Benefits, Director of Retired Members, and a three-member Board of Trustees. Nominations of fifteen (15) National Business Agents shall be separately by NALC Regions, as constituted effective January 1, 1974. Only delegates from the appropriate NALC Region may nominate candidates for the position of National Business Agent for such Region. Nomination to the position of National Business Agent in each Region shall be restricted to nominees whose Branch is located in such appropriate NALC Region. No person shall be nominated for any office without his/her written acceptance, on the officially prescribed forme, which must include the endorsement from five (5) delegates representing five (5) Branches. The official forms shall be handed to the Secretary-Treasurer at the time of nomination, and no person shall be permitted to accept nomination for more than one office at any Convention. No second shall be necessary to a nomination, and no nominating speeches will be permitted by the Chair. No nominee who filed acceptance with the Secretary-Treasurer shall be allowed to withdraw his/her name. When there is but one candidate placed in nomination, the Chairperson shall declare the election by consent.

NALC Executive Council

Amend Article 6, Section 2 as follows:

Every four(4) years, nominations for officers of the Union shall be called by the Chairperson of the Convention. The Chair shall call for the nominations from the floor for each national office separately. Any delegate may nominate an eligible member for any one of the following national offices: President, Executive Vice President, Vice President, Secretary-Treasurer, Assistant Secretary-Treasurer, Director of City Delivery, Director of Safety and Health, Director of Retired members, and a three member Board of Trustees. Nominations of fifteen(15) National Business Agents shall be separately by NALC Regions, as constituted effective January 1, 1974. Only delegates from the appropriate NALC Region may nominate candidates for the position of National Business Agent for such Region. Nomination for the position of National Business Agent in each region shall be restricted to nominees whose Branch is located in such appropriate NALC Region. No person shall be nominated for any office without his/her written acceptance, on officially prescribed forms, which must include the endorsement from fifty(50) members in good standing from the respective Region where appropriate. Election forms shall be available on the NALC Official website. The official forms shall be handed to the Secretary-Treasurer at the time of the nomination, and no person shall be permitted to accept nomination for more than

one office at any Convention. These nominating forms shall be made immediately available by the Secretary-Treasurer for review by all candidates at the close of nominations. No second shall be necessary to a nomination, and no nominating speeches will be permitted by the Chair. No nominee who filed acceptance with the Secretary-Treasurer shall be allowed to withdraw his/her name. When there is but one candidate placed in nomination, the Chairperson shall declare the election by consent.

#### Constitution for the Government of Subordinate and Federal Branches

#### **Meetings**

Amend Article 3, Section 5 as follows:

In the absence of the President and Vice President, any member in good standing may be elected to preside by a majority of those present. However, Branches in their By-laws may designate one or more officer(s) to preside in the absence of the President and Vice President.

NALC Executive Council

Amend Article 3, Section 5 as follows:

In the absence of the President and Vice President, the next officer in line shall preside. However, in the absence of all officers, any member in good standing may be elected to preside by a majority of those present.

Branch 1492, Westfield, NJ

#### **Elections**

Amend Article 5, Section 2 as follows:

All regular members must be a member in good standing for 90 days prior to nomination to be eligible to hold any office or position in the Branch, except that a member who voluntarily or otherwise, holds, accepts, or applies for a supervisory position in the Postal Career Service for any period of time, whether one(1) day or fraction thereof, either detailed, acting, probationary or permanently, shall immediately vacate any office held, and shall be ineligible to run for any office or other position for a period of two(2) years after termination of such supervisory status. Upon nomination, the candidate must verify that he or she has not served in a supervisory capacity for the 24 months prior to the nomination.

Amend Article 5, Section 3 as follows:

Section 3. All regular members shall be entitled to one vote for each office or position to be filled. However, station delegates, representatives, or shop stewards shall may be elected only by the regular members within the station or area they represent. Branch stewards and any other persons who are members of the Branch Executive Board or similar body must be elected by the entire branch, not just by the station or area they represent.

NALC Executive Council

Amend Article 5, Section 5 (a) as follows:

Prior to the nominations of a candidate, a nominating petition on behalf of such candidate, specifying the office sought and containing the signatures of members as fol-

lows must be submitted to the Recording Secretary.

Branches with up to 100 members 1 signature of a regular member in good standing.

Branches with 101 to 200 members 2 signatures of regular members in good standing.

Branches with 201 to 300 members 3 signatures of regular members in good standing.

Branches with 301 to 400 members 4 signatures of regular members in good standing.

Branches with 401 to 500 members 5 signatures of regular members in good standing.

Branches with 501 to 1000 members 10 signatures of regular members in good standing.

Branches with 1001 to 2000 members 20 signatures of regular members in good standing.

Branches with 2001 to 3000 members 25 signatures of regular members in good standing.

Branches with 3001 or more members 30 signatures of regular members in good standing.

#### **Duties of Officers**

Amend Article 6 by adding the following new Section 11:

#### Bonding

Section 11. Every officer, agent, shop steward, or other representative or employee of the Branch who handles funds or other property of the Branch shall be bonded to the extent required by applicable law.

NALC Executive Council

#### Charges

Amend Article 10, Section 2 as follows:

Section 2. Charges must be made in writing, specifying the offense, failure, neglect, or misconduct so as to fully apprise the member or officer of the nature thereof, and shall be signed by a member of the Branch; and a copy of said charges, under seal **or letterhead** of the Branch, shall be served upon him/her. Said charges shall be read by the recording secretary at the first regular Branch meeting after service on the member or officer.

## CONSTITUTION OF THE GOVERNMENT OF STATE ASSOCIATIONS

#### Meetings

Amend Article 3, Section 1 as follows:

Section 1. This Association shall meet at least once every two three years, at such time and place as may be designated in the by-laws or decided upon by a majority vote at a previous session unless conditions should arise which require a change in the date and place decided upon or designated, when the President and Executive Board shall have authority to make such change of time or place and report same through the Secretary.

## CONVENTION WORKSHOPS

#### MONDAY MORNING

## Contract Administration Unit Briefing and Q-and-A

Executive Vice President Timothy C. O'Malley will be joined by other national officers and staff who serve in the Contract Administrative Unit (CAU). The CAU will report on pending cases at the National Interpretive Step level or Arbitration and any recent settlements. The CAU will discuss in detail the "the daily dialogue" that takes place in the workplace with your supervisor concerning mail volume, work expectations and receiving assistance. We will explain how and what to do in difficult situations and what to do to attain a better work environment. A booklet containing information related to this will be provided. A question-and-answer period will follow and give the delegates the opportunity to seek clarification on the issues raised and to provide comment and feedback to the CAU.

#### **Effective Branch Communications**

Branch publications, both traditional print and web-based electronic, can be a formidable force for informing and activating NALC members. This workshop will provide tips for producing first-class, direct-to-the-member communications. Designer/Web Editor Mike Shea, Internet Communications Coordinator Joe Conway and Writer/Editor Rick Hodges will discuss ways of improving websites and e-mail newsletters, effectively using social media and sharpening the focus and effectiveness of conventional newsletters and traditional communications strategies. NALC's Branch Publication Competition winners will be announced at this workshop.

#### **Stewards Training School**

For the first time at National Convention, the NALC is offering a week-long training school for shop stewards that will cover grievance-handling from the investigation of an incident through the arbitration of a grievance. The school will consist of five classes, one offered each morning and repeated in the afternoon to enable those interested to attend other offerings as well. As we move through the week, the students will learn about the various aspects of investigating, preparing and presenting grievances at Informal A, Formal A and Step B of the grievance process. We also will follow a specific grievance as it moves through this process and is ultimately heard before an arbitrator. The classes are:

Monday: Steward Rights—Before stewards can enforce the rights of others, they must understand what their own rights are and be able to enforce them. This session will cover the rights and responsibilities that stewards have under the National Agreement and the National Labor Relations Act and what stewards can do to enforce these rights in their units.

**Tuesday: Grievance Investigation and Research**—A member comes to the steward with a problem. What's next? This class covers the steps of investigating a potential grievance, including getting the time from management, interviewing friendly as well as reluctant witnesses,

taking good notes, and asking for and reviewing documentary evidence. The class will also cover research techniques using materials and resources available to stewards on the NALC website, the Contract Administration DVD and the Arbitration DVD program.

Wednesday: Preparing and Presenting Grievances at Informal Step A—With the investigation and research done, the steward must now prepare and present the grievance at Informal Step A. This class will show stewards how to organize the file and prepare for the meeting with management, including writing a position page and preparing documents. We also will cover presenting the grievance to management at the Informal meeting and methods and techniques for reaching reasonable remedies. Making appeals of unresolved grievances to Formal A will end this session.

Thursday: Preparing and Presenting Grievance at Formal Step A—The case is unresolved at the Informal meeting and the steward appeals it to the next step. This session will cover what the union should do to prepare the case for the Formal Step A meeting. This will include reviewing and completing the file, preparing for the meeting, preparing a list of "undisputed facts," conducting the meeting and appealing unresolved cases.

Friday: Grievance Arbitration—The class will only be offered on Friday morning. It consists entirely of the mock arbitration of a grievance that the class has been following throughout the week from the investigation of the incident through the steps of the grievance procedure to arbitration. Stewards will see how various things that occurred during the processing of the grievance affect the ultimate outcome of the case.

#### Monday Afternoon

#### **Branch Trustee Training**

Under the NALC Constitution, branch trustees are required to "examine and report to the branch the condition of the books of the officers at least once very six months," but many local trustees lack a clear understanding of all the intricacies their duties entail. of National Board of Trustees Chairman Larry Brown and National Trustees Randy Keller and Mike Gill will provide local trustees with information and a variety of tools they need to keep their branches on the right track. Among the topics covered will be getting ready for an audit, receipts and disbursements, Labor-Management Reporting and Disclosure Act requirements, and overall union finances

## Contract Administration Unit Briefing and Q-and-A

Same as Monday morning.

#### **Health Benefit Workshop**

Heath Benefit Plan Director Brian Hellman and several training instructors will bring branch presidents and health benefit representatives up to date on the status of the Plan, current benefits and the direction the Plan hopes to take during the upcoming benefit year, especially with respect to the Affordable Care Act (ACA). Our instructors also will take some time to familiarize representatives on how to teach current and potential members of the Plan new/existing benefits and how to "sell" the Plan. At the end of the session, there will be a question-and-answer period to further address any concerns. Registration is required; however, no fee will be assessed.

#### Community Service: The Importance of Your Branch in the Community

Letter carriers are the friendliest, most reliable and dependable members in the community. We help those in need and, in doing so, we preserve the Postal Service's reputation as the most trusted government organization. How do we do it? What can your branch do? Come find out how your members can make a difference, both on our routes and in our neighborhoods. You will meet some real-life letter carrier heroes whose service goes above and beyond the call of delivering the mail. We will share ideas on fundraising, provide "road maps" for success, and ensure that letter carriers remain the heart and soul of their communities.

### **Stewards Training School: Steward Rights**

Same as Monday morning.

#### Tuesday morning

#### City Delivery Briefing and Q-and-A

Director of City Delivery Lew Drass and his staff will provide updates and information on various city delivery issues such as route count and inspections, FSS, delivery unit optimization (DUO) and management's unilateral caser/ streeter test. The majority of this workshop will be spent training delegates on several key elements of successful route count and inspection grievances.

#### **Understanding the LM-3**

This class will help participants understand and complete the Form LM-3. Bond Beebe Accountants and Advisors President David Dorsey will review the form with participants to determine what information the DOL is really asking for and what details must be included with the answers. Among the areas to be covered are: the proper way to complete Item 24, listing all officers and disbursements to officers, and where to report different kinds of receipts and disbursements. A completed LM-3 for a hypothetical branch will be distributed to help branch leaders in preparing and reviewing their own branch LM-3 filing. Dorsey plans to stay after class to answer individual questions and concerns.

#### Social Security and the TSP

The Social Security class will be presented by the SSA Regional Office. It is intended to give a general overview of how Social Security works and provide the participants with an up-to-date vision of the program. The TSP portion will be

presented by the Thrift Investment Board and is intended to provide "withdrawal" rights and tax ramifications for retirees or others leaving the federal workforce.

## Stewards Training School: Grievance Investigation and Research

A member came to the steward with a problem. What's next? This class covers the steps of investigating a potential grievance, including getting the time from management, interviewing friendly as well as reluctant witnesses, taking good notes, and asking for and reviewing documentary evidence. The class also will cover research techniques using materials and resources available to stewards on the NALC website, the Contract Administration DVD and the Arbitration DVD program.

#### Congressional District Liaison Training: Effective Grassroots Activism

The work of NALC's congressional district liaisons (CDLs) in mobilizing NALC members and educating members of Congress is a key component to ensure that letter carriers' rights are protected as Congress debates the future of the USPS. Highlights of the workshop include: tips for successful lobbying, messaging techniques, enlisting like-minded allies to support NALC's agenda and a discussion of best practices of CDLs. This training is open to CDLs only.

### Mutual Benefit Association: Planning for Your Life

MBA Director Myra Warren will present a workshop on financial planning with special emphasis on life insurance needs. This workshop will outline a financial planning model that will allow letter carriers to determine the amount of life insurance that is needed to ensure a sound future. In addition, the workshop will review the costs of final expenses. In an attempt to help our members meet their insurance needs, the MBA products such as Whole Life, Term Life, Universal Life, Hospital Confinement and Maturity Income plans will be discussed.

#### Tuesday afternoon

#### City Delivery Briefing and Q-and-A

Same as Tuesday morning.

#### New Fiduciary Officer Training: What You Need to Know about Finance, Membership and Recordkeeping

This workshop is intended for new branch officers who have fiduciary and recordkeeping responsibilities—presidents, secretary-treasurers and trustees. Attendees will be introduced to Department of Labor requirements, including bonding, member rights and fiduciary officers' responsibilities under the Labor Management and Reporting Disclosure Act of 1959. Also discussed will be tax issues, including setting up payroll, recordkeeping dos and don'ts, and the various membership rosters. NALC staff from

the Membership Department, Finance, and the Information Center will assist Secretary-Treasurer Jane Broendel in covering these important topics.

#### FERS-Using it for Your Future

This class, presented by Director of Retired Members Ernie Kirkland, will give a thorough overview of the Federal Employees Retirement System (FERS). It will assist the participant in understanding the basis for their retirement system as well as the Supplemental annuity. The class will look at when and how to prepare for retirement from initial employment up to and through the retirement application process.

## Stewards Training School: Grievance Investigation and Research

Same as Tuesday morning.

#### **Global Postal Services**

This workshop will give delegates the chance to learn about postal developments in other countries and to meet and discuss these developments with the NALC's guests from our global union federation, UNI Global Union and postal unions from other countries. Postal workers and their unions all over the world are grappling with the same challenges that NALC faces—the Internet, competition and hostile governments. The workshop, which will be moderated by headquarters staffer Pam Donato, offers a chance to learn from each other while building international solidarity.

## WEDNESDAY MORNING

The focus of this workshop will be training delegates on ways to file successful Article 12 grievances. Director of City Delivery Lew Drass and his staff will provide a blueprint on how to properly document and argue the NALC's case when management violates Article 12 by improperly withholding positions and/or improperly excessing employees.

### NALC Legislative and Political Agenda

This workshop will provide an overview of the 112th Congress as it pertains to postal reform and other issues pertaining to federal employees. Director of Legislative and Political Affairs Jennifer Warburton will discuss the impact of current legislation as well as provide insight on possible postal reform bills that could be passed before the end of the year. Political Director Tucker McDonald will recap the NALC's efforts to affect the legislative process in the field as well as outline the current political landscape going into the presidential campaign as well as the NALC and the labor movement's campaign to support and elect labor-endorsed candidates in November.

#### Safety and Health

Director of Safety and Health Manuel Peralta will be conducting a workshop on the Article 14 duties and responsibilities of shop stewards. Peralta will be accompanied by the NALC's National Safety Task Force, which will discuss a few of its activities. The focus of the class it to learn from our past and prevent pain in the future. Also scheduled to participate in the session are representatives from OSHA, who will address their role in assisting the NALC on providing a safe work environment. They will also cover OSHA's whistle-blower protection and address the Labor Liaison Program, explaining its purpose.

#### Stewards Training School: Preparing and Presenting Grievances at Informal Step A

With the investigation and research done, the steward must now prepare and present the grievance at Informal Step A. This class will show stewards how to organize the file and prepare for the meeting with management, including writing a position page and preparing documents. We will also cover presenting the grievance to management at the Informal meeting and methods and techniques for reaching reasonable remedies. Making appeals of unresolved grievances to Formal A will end this session.

We must look beyond the immediate USPS financial crisis and the headlines reporting our demise and boldly think of the USPS' future. With our experience and ingenuity, letter carriers are best positioned to identify new product and service growth, discover expanding markets and improve efficiencies in our postal systems and methods. #### Swimming with Sharks: Guiding the Accepted OWCP Claim through Perilous Waters

Many injured letter carriers think that once OWCP accepts their claim, their struggle is over. Often it is only just beginning. This class explores some of the hazards letter carriers encounter after their claim is accepted. The class will cover a range of topics: expanding claims to include more serious actual conditions; confronting complications that arise when the accepted injury involves a pre-existing condition; communicating with the attending physician; dealing with OWCP-directed medical examinations; challenging lost wage earning capacity determinations; and understanding the different types of OWCP decisions to select the proper route of appeals

## Health Benefit Workshop for all Attendees

Heath Benefit Plan Director Brian Hellman and several training instructors will bring workshop attendees up to date on the status of the Plan, current benefits, and general Health Plan information. At the end of the session, there will be a question-and-answer period to further address any concerns. This year there will be no registration process or fee; however, seating will be on a first-come, first-served basis.

#### CSRS—What's In It for You?

This class, presented by Director of Retired Members Ernie Kirkland, will give a thorough overview of the Civil Service Retirement System (CSRS). It will assist the participant in understanding the basis for their retirement system as well as a look at the Windfall Elimination Provision and Government Pension Offset that might affect any Social Security entitlement an employee has accrued through outside employment. The class will look at the retirement application process and discuss time lines for finalization of the annuity.

#### Stewards Training School: Preparing and Presenting Grievance at Formal Step A

The case is unresolved at the Informal meeting and the steward appeals it to the next step. This session will cover what the union should do to prepare the case for the Formal Step A meeting.

This will include reviewing and completing the file, preparing for the meeting, preparing a list of "undisputed facts," conducting the meeting and appealing unresolved cases.

#### **NALC & MDA: A Team that Delivers**

What would you do if someone in your family was diagnosed with one of the more than 40 diseases covered by the Muscular Dystrophy Association? Come hear what services MDA provides to give help and hope to those who hear that diagnosis. Join us to meet MDA's new goodwill ambassador, Bryson Foster, along with his parents Phil and Claire of Concord, NC. In addition, we will hear the latest on the research front from MDA's own medical experts. Finally, come to share your success stories with your brothers and sisters so that we can increase our efforts for the families MDA supports.

### Taking Advantage of the Thrift Savings Plan

Representatives of the Federal Retirement Thrift Investment Board will be on hand to present a comprehensive workshop on the federal Thrift Savings Plan. Retirement savings are crucial for retirement security and the TSP is the smartest way to save for a comfortable retirement. TSP administrators will highlight plan developments, including the new Roth TSP options, and answer delegates' questions about taking full advantage of the federal government's "401(k)."

The workshop will also cover common problems with bylaws and how to get that stamp of approval from the Committee of Laws.

The class will deal with broad media strategy and practical details of talking to a reporter.

### Stewards Training School: Grievance Arbitration

It consists entirely of the mock arbitration of a grievance that the class has been following throughout the week, from the investigation of the incident through the steps of the grievance procedure to arbitration.
